SCHUYLKILL COUNTY**

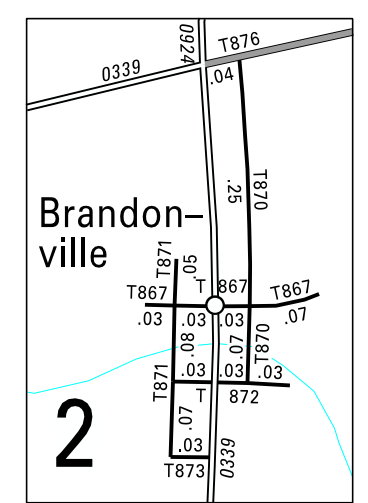
